(Amendment) Order 2010

The Conwy County Borough Council proposes to make an Order under Sections 1(1),2(1) to (3) and Part IV of Schedule 9, of the Road Traffic Regulation Act 1984, which will amend the The County Borough of Conwy (A548 Llanfair Road Abergele) (40 M.P.H. Speed Limit) Order 2010 the effect of which will be to amend the distance of the speed restriction as specified in the Schedule below.
