RHODDIR RHYBUDD fod Cyngor Bwrdeistref Sirol Conwy yn bwriadu gwneud Gorchymyn, ddim llai na saith niwrnod wedi dyddiad y Rhybudd hwn, i wahardd unrhyw un rhag achosi i unrhyw gerbyd fynd ar hyd y darn hwnnw o Bayview Road, Bae Colwyn, sy'n estyn o'i chyffordd â Seaview Road i'w chyffordd â Greenfield Road, Bae Colwyn. Trefnwyd y bydd y ffordd yn cael ei chau o 11 Ebrill mewn 3 cham fel a ganlyn:

- Cam 1: 11 Ebrill 2010 08.00 – 16.00
Cam 2: 18 Ebrill 2010 15.00 – 18.00
Cam 3: 9 Mai 2010 08.00 – 16.00

Dyddiadau dros dro yw'r rhain ac maent yn dibynnu ar y tywydd. Bydd y ffordd ar gau pan fydd arwyddion priodol W7010.4 yn cael eu harddangos.

Y mae angen y Gorchymyn I hwylyso gwaith gan Buckleys Crane Hire

Y llwybr teithio arall i gerbydau yw ar hyd Seaview Road i Conway Road i Penrhyn Road i Rhodfa'r Tywysog a Victoria Avenue i Greenfield Road.

Bydd y Gorchymyn yn dod i rym 11 Ebrill 2010. Disgwylir y bydd y cyfyngiad mewn grym am 6 wythnos fan bellaf, neu nes bydd y gwaith y bwriedir ei wneud arni wedi ei gwblhau.

ROAD TRAFFIC REGULATION ACT 1984

SECTION 14(1)

**The County Borough of Conwy
(Bayview Road Colwyn Bay)**

**(Temporary Prohibition of Through Traffic
Order 2010)**

NOTICE IS GIVEN that the Conwy County Borough Council intend not less than seven days from the date hereof to make an Order, the effect of which will be to prohibit any person from causing any vehicle to proceed in that length of Bayview Road Colwyn Bay which extends from its junction with Seaview Road to its junction with Greenfield Road Colwyn Bay. The road closures are scheduled to start on 11th April 2010 and intended to be carried out in 3 phases as follows:

- Phase 1: 11th April 2010 – 08.00 – 16.00
Phase 2: 18th April 2010 – 15.00 – 18.00
Phase 3: 9th May 2010 – 08.00 – 16.00

These dates are provisional and weather dependent. The road will be closed when the appropriate traffic signs W7010.4 are in place.

The Order is necessary to facilitate work by Buckleys Crane Hire.

The alternative route is via Seaview Road onto Conway Road onto Penrhyn Road to Princes Drive onto Victoria Avenue onto Greenfield Road and will be signposted accordingly.

The Order comes into effect on 11 April 2010. It is anticipated that the restriction will be in place for a maximum period of 6 weeks, or until the works which it is proposed to carry out thereon has been completed.
