

Gorchymyn (Cydgrynhoi) Bwrdeistref Sirol Conwy (Atal A Chyfyngu Aros A Mannau Parcio Oddi Ar y Stryd) 2006 Gorchymyn (Diwygiad Rhif 1) 2010

Y mae Cyngor Bwrdeistref Sirol Conwy wedi gwneud Gorchymyn dan Adranau 1(1), 2(1) i (3) a Rhan IV Atodlen 9, Deddf Rheoli Trafnidiaeth Fyrrd 1984, i ddiwygio Gorchymyn Cydgrynhoi Cyngor Bwrdeistref Sirol Conwy (Gwahardd a Chyfyngu ar Aros a Mannau Parcio ar y Stryd) 2006 mewn perthynas â Rhan VI – Parth Parcio a Reolir ac Atodlenni 1 i 6 at hynny. Bwriad y Gorchymyn yw ymestyn y Parth Parcio a Reolir, cadarnhau cyfradd y taliadau a diwygio/ychwanegu diffiniadau. Mae rhestr o'r darnau ffordd a fydd yn cael eu ychwanegu yn Atodlenni 1-6 ac mae cadarnhad o'r taliadau wedi eu cynnwys yn Atodlenni 2 a 4 y Rhybudd.

The County Borough of Conwy (Prohibition And Restriction Of Waiting & On Street Parking Places) (Consolidation) Order 2006 (Amendment No 1) Order 2010

The Conwy County Borough Council has made an Order under Sections 1(1),2(1) to (3) and Part IV of Schedule 9, of the Road Traffic Regulation Act 1984, which will amend the Conwy County Borough Council (Prohibition and Restriction of Waiting and On Street Parking Places) Consolidation Order 2006 insofar only as it relates to Part VI – Controlled Parking Zone and Schedules 1 to 6 thereto. The effect of the Order is to extend the Controlled Parking Zone, confirm the scale of charges and amend/add definitions. The lengths of road added are referred to in Schedules 1 – 6 hereto and confirmation of charges are specified in Schedules 2 and 4 to this Notice.

A copy of the Order, which will come into operation on 19 April 2010 and a map showing the lengths of road to which the Order relates may be examined at the offices of the Head of Legal and Democratic Services, Bodlondeb, Conwy LL32 8DU during normal office hours.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, you may, within six weeks from the date of this notice apply to the High Court for this purpose.
