(Gwahardd a Chyfyngu ar Aros) 2010

 4. Diddymu'r cyfyngiad aros ar y rhan o ffordd a nodwyd yn Atodlen 4
 5. Diddymu'r Man Parcio Meddygon dynodedig ar y rhan o ffordd a nodwyd yn Atodlen 5
 6. Diddymu'r man llwytho coetsus ar y rhan o ffordd a nodwyd yn Atodlen 6

The Conwy County Borough Council (The Parade & Various Streets Llandudno)
(Prohibition and Restriction of Waiting) Order 2010

On the 8 April 2010 the Conwy County Borough Council made the above-named Order under Sections 1 and 2 of the Road Traffic Regulation Act 1984, the effect of which is to

1. Designate the length of road specified in Schedule 1 as Coach/Loading Bay
2. Designate the length of road specified in Schedule 2 as Coach/Loading Bay between the hours of 9am-6pm
3. Provide an exemption for permit holders to the existing limited waiting 9am to 5pm on the lengths of road specified in Schedule 3
4. Revoke the limited waiting on the length of road specified in Schedule 4
5. Revoke the designated Doctors Parking Bay on the length of road specified in Schedule 5
6. Revoke the coach loading bay on the length of road specified in Schedule 6

Exceptions are provided in the Order to permit waiting for the purposes of alighting, boarding, loading, unloading and works of maintenance, repair and the like.

Vehicles displaying a disabled person's badge will be allowed to wait for an unlimited period of time in the lengths of roads specified in Schedule 3 to this Notice.

A copy of the Order, which will come into operation on 19 April 2010, and a map showing the lengths of road to which the Order relates may be examined at the offices of the Head of Legal & Democratic Services, Bodlondeb, Conwy LL32 8DU during normal office hours.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, you may, within six weeks from the date hereof apply to the High Court for this purpose.

Schedule 1
(Coach/Loading Bay)

The Parade	South-western side; from a point 5 metres north-west of its junction with Trevor Street for a distance of 19 metres in a north-westerly direction.

Schedule 2
(Coach/Loading Bay 9:00am to 6:00pm)

Happy Valley Road	South easterly side; from the south-western end of the coach parking bay in front of the Grand Hotel for a distance of 8 metres in a south-westerly direction.

Schedule 3
(Existing Limited waiting 90 minutes, no return within 120 minutes, 9am to 5pm - exemption for permit holders.)

St. George's Place	Easterly side a) From a point 14 metres south of its junction with The Parade to a point 11 metres north of its junction with Somerset Street. b) From a point 11 metres south of its junction with Somerset Street to a point 11 metres north of its junction with Mostyn Street. Westerly side c) From a point 6 metres south of its junction with The Parade to a point 11 metres north of its junction with Ty Isa Road. d) From a point 11 metres south of its junction with Ty Isa Road to a point 11 metres north of its junction with Mostyn street.
Clonmel Street	Easterly side e) From a point 10 metres south of its junction with The Parade to a point 7 metres north of its junction with Bodafon Street f) From a point 7 metres south of its junction with Bodafon street to a point 11 metres north of its junction with Mostyn Street. Westerly side g) From a point 6 metres south of its junction with The Parade to a point 7 metres north of its junction with Somerset Street. h) From a point 7 metres south of its junction with Somerset Street to a point 11 metres north of its junction with Mostyn Street.

Schedule 4
(Limited waiting 60 minutes, no return within 120 minutes, 10am to 4pm, to be revoked)

The Parade	South-western side; a) From a point 24 metres north-west of its junction with Trevor Street for a distance of 24 metres in a north-westerly direction. b) From a point 66 metres north-west of its junction with Trevor Street for a distance of 38 metres in a north-westerly direction.

Schedule 5
(Doctors parking to be revoked)

The Parade	North-easterly side; from a point 24 metres north-west of its junction with Trevor Street for a distance of 31 metres in a north-westerly direction.

Schedule 6
(Coach/Loading bay to be revoked)

The Parade	South-western side; from a point 17 metres south-east of its junction with St. George's Place for a distance of 19 metres in a south-easterly direction.
