

Gorchymyn Bwrdeistref Sirol Conwy
(A548 Llanfair Road Abergele)

Ar 16 Ebrill 2010 gwnaeth Cyngor Bwrdeistref Sirol Conwy y Gorchymyn a enwir uchod dan Adranau 1(1), 2(1) i (3) a Rhan IV Atodlen 9, Deddf Rheoli Trafnidiaeth Ffyrdd 1984, i ddiwygio Gorchymyn Bwrdeistref Sirol Conwy (A548 Llanfair Road Abergele) (Cyfyngiad Cyflymdra 40 M.Y.A.) 2010 i wahardd unrhyw un rhag gyrru cerbyd modur ar gyflymdra sydd yn uwch na 40 milltir yr awr yn y darn ffordd a nodir yn yr Atodlen i'r Gorchymyn hwn.

(40 M.P.H. Speed Limit) Order 2010
(Amendment) 2010

On 16 April 2010 Conwy County Borough Council made the above-named Order under Sections 1(1), 2(1) to (3) and Part IV of Schedule 9, of the Road Traffic Regulation Act 1984 to amend the County Borough of Conwy (A548 Llanfair Road Abergele) (40mph Speed Limit) Order 2010 the effect of which is to prohibit any person from driving any motor vehicle at a speed exceeding 40 miles per hour in the length of road specified in the Schedule hereto.

A copy of the Order, which will come into operation on 26 April 2010 and a map showing the length of road to which the Order relates may be examined at the offices of the Head of Legal & Democratic Services, Bodlondeb, Conwy LL32 8DU during normal office hours.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, you may, within six weeks from the date of this Notice apply to the High Court for this purpose.

SCHEDULE

A548 Llanfair Road Abergele From a point 120 metres south of its junction with Lôn Dirion to a point 150 metres south of the road known as Twll Llwynog for a distance of approximately 330 metres.
