

COAST PROTECTION ACT 1949

APPLICATION FOR COAST PROTECTION ACT CONSENT FOR THE CONSTRUCTION OF A BERTHING JETTY WITHIN THE RIVER DEE, NORTH WALES

Notice is hereby given that Airbus Operations Limited has applied, to the Welsh Assembly Government's Marine Consents Unit acting on behalf of the Secretary of State for the Department of Transport under Section 34 of the Coast Protection Act 1949, as amended by Section 36 of the Merchant Shipping Act 1988, for consent to undertake the construction of a berthing jetty within the River Dee, North Wales.
