

**Gorchymyn Bwrdeistref Sirol Conwy  
(Ffyrdd Amrywiol - Dwygyfylchi)  
(Cyfyngiad Cyflymder 30 M.Y.A.) 2010**

Mae Cyngor Bwrdeistref Sirol Conwy yn bwriadu gwneud Gorchymyn dan Adran 84(1) a (2) Deddf Rheoli Trafnidiaeth Ffyrdd 1984 fydd yn gwahardd unrhyw un rhag gyrru cerbyd modur ar gyflymder sydd yn uwch na 30 milltir yr awr ar y rhannau ffordd a nodir yn Atodlen 1, ac i ddiddymu'r cyfyngiad ar y rhan o'r ffordd a nodwyd yn Atodlen 2.

Old Mill Road	O'i chyffordd gyda Sychnant Pass Road hyd at bwynt sydd 24 metr i'r gogledd orllewin o lwybr Glyn.
Sychnant Pass Road	O'i chyffordd gyda Old Mill Bridge am bellter o 27 metr tua'r gogledd ddwyrain.

**The Conwy County Borough of Conwy  
(Various Roads - Dwygyfylchi)  
(30 M.P.H. Speed Limit) Order 2010**

The Conwy County Borough Council proposes to make an Order under Section 84(1) and (2) of the Road Traffic Regulation Act 1984 the effect of which will be to prohibit any person from driving any motor vehicle at a speed exceeding 30 miles per hour in the lengths of road specified in Schedule 1 and to derestrict the length of road specified in Schedule 2.

A copy of the proposed Order, together with a map showing the length of road to which the proposed Order relates and a statement of the Council's reasons for proposing to make the Order may be examined at the offices of the Acting Head of Legal Services, Bodlondeb, Conwy and at Penmaenmawr Library during normal opening/office hours.

Objections to the proposed Order, together with the grounds on which they are made should be sent to the Acting Head of Legal Services, Bodlondeb, Conwy, LL32 8DU by 1 September 2010.

**Schedule 1**

**(30mph Speed limit)**

Glan-yr-Afon Road	From its junction with The Gardens to the cattle grid a distance of 300 metres in a northerly direction.
Old Mill Road	From its junction with Sychnant Pass Road to a point 24 metres north west of Glyn Path.
Sychnant Pass Road	From its junction with Old Mill Bridge for a distance of 27 metres in a north easterly direction.

**Schedule 2**

**(De-restrict currently restricted by a system of street lighting)**

Glan-yr-Afon Road (Junction Westbound)	From its junction with Penmaenmawr By-Pass Westbound for a distance of 52 metres in a southerly direction.
