Mae Cyngor Sir Ddinbych wedi gwneud Gorchymyn a fydd yn:

1) Gosod cyfyngiad cyflymder dros dro o 10 mya ar hyd y ffordd A525 yn Llandegla, o bwynt sydd oddeutu 1,334 metr o gyffordd yr A542 i gyfeiriad dwyreiniol am bellter o oddeutu 4,432 metr, a bydd yn gymwys pan fydd gwaith confoi mewn grym ar unrhyw ddiwrnod penodedig; a

2) Gwahardd pob cerbyd rhag goddiweddyd ar yr hyd o'r ffordd a enwyd.

Y rheswm am y cyfyngiad yw hwyluso gwaith confoi yn ystod gwaith ail-wynebu gan Gyngor Sir Ddinbych - Cynnal.

Daw'r Gorchymyn i rym ar Awst 9fed 2010 a bydd yn dal mewn grym am gyfnod o ddeunaw mis neu hyd gwblhau'r gwaith pa un bynnag yw'r cynharaf. Rhagwelir y cymer oddeutu 3 mis i gwblhau'r gwaith.

NOTICE OF TEMPORARY 10 MPH SPEED RESTRICTION AND NO OVERTAKING ORDER 2010

ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14

Denbighshire County Council has made an Order which will :-

1) Impose temporarily a 10 mph speed limit along the A525 road at Llandegla, from a point approximately 1,334 metres from the junction of A542 in an easterly direction for a distance of approximately 4,432 metres, which will apply when convoy work is in force on any given day; and

2) Prohibit all vehicles from overtaking in the said length of road.

The reason for this restriction is to facilitate convoy working during resurfacing works by Denbighshire County Council - Maintenance.

The Order comes into force on 9th August 2010, and will remain in force for a period of eighteen months or until the completion of the works whichever is the earlier. It is anticipated that the works will take approximately 3 months to complete
