



TEMPORARY TRAFFIC ORDER

Notice of Temporary Prohibition of Through Traffic Order

Road Traffic Regulation Act 1984 - Section 14 B5433 Gatewen Road, Caego

The Wrexham County Borough Council intends not sooner than seven days from the 6th August 2010 to make an order which will prohibit any vehicle from using that length of the B5433 Gatewen Road, Caego in the County Borough of Wrexham which extends from its junction with Hall View for a distance of approximately 300 metres in a southwesterly direction to adjacent the property known as "Wenallt".

The reason for closure is because works are being or are proposed to be executed on or near the road and because of the likelihood of danger to the public in order to enable Bloor Homes North West to undertake highway construction works. The alternative route available for traffic will be via B5101 Berse Road, Dale Road and B5433 Gatewen Road and will be signposted accordingly.

Pedestrian access will be maintained throughout the period of closure. Access will be maintained throughout the period of closure for emergency vehicles.

This Order will come into force on the 23 August 2010. It is anticipated that the road will only be closed for a period of 12 weeks, or until the early completion of the works and subject to a maximum period of 18 months.

Mae Cyngor Bwrdeistref Sirol Wrecsam yn bwriadu gwneud Gorchymyn heb fod ynghynt na saith niwrnod o 6ed Awst 2010 a fydd yn gwahardd unrhyw gerbyd rhag defnyddio'r B5433 Ffordd Gatewen, Caego ym Mwrdeistref Sirol Wrecsam sy'n ymestyn o'i chyffordd â Hall View am oddeutu 300 metr i gyfeiriad de-orllewinol i gyferbyn ag eiddo o'r enw "Wenallt."
