



TEMPORARY TRAFFIC ORDER

Notice of Temporary Prohibition of Through Traffic Order

Road Traffic Regulation Act 1984 - Section 14 B5433 Gatewen Road, Caego

Wrexham County Borough Council has made an Order which will prohibit any vehicle from using that length of B5433 Gatewen Road, Caego in the County Borough of Wrexham which extends from its junction with Hall View for a distance of approximately 300 metres in a southwesterly direction to adjacent the property known as "Wenallt".

The reason for the closure is because works are being or are being proposed to be executed on or near the road and because of the likelihood of danger to the public in order to enable Bloor Homes North West to undertake highway construction works.

The alternative route available for traffic is via B5101 Berse Road, Dale Road and B5433 Gatwen Road and will be signposted accordingly. Pedestrian access will be maintained throughout the period of closure. Access will be maintained throughout the period of closure for emergency vehicles.

This Order comes into force on the 23 August 2010 and will continue in force for a period of 18 months, or until the works are completed, whichever is the soonest.
