**The Highways Act 1980**

**Gorchymyn Gywro Llwybr Cyhoeddus Cyngor Sir Powys (Gwyro rhannau o Lwybrau Cyhoeddus 14 a 15 yng Nghymuned Llanfechain) 2010**

**The Powys County Council (Diversion of parts of Public Footpath 14 and 15 in the Community of Llanfechain) Public Path Diversion Order 2010**

Ar 29 Gorffennaf 2010 cadarnhaodd Cyngor Sir Powys y Gorchymyn uchod dan Adran 119 Deddf Prifffyrdd 1980.

On 29 July 2010 Powys County Council confirmed the above Order made under Section 119 of the Highways Act 1980.

Effaith y Gorchymyn fel y'i cadarnhawyd yw gwyro rhannau o lwybr troed 14 sy'n rhedeg o SJ19172093 i SJ19302087 hyd at linell sy'n rhedeg o SJ19172093 ar lein yn ffinio â'r ffos draenio i SJ19302087 ac o SJ19302086 i SJ19372076 i SJ19402069 hyd at linell sy'n rhedeg o SJ19302086 i SJ19342074 i SJ19402069 ac o SJ19482049 i SJ19492048 hyd at linell sy'n rhedeg o SJ19482049 i SJ19492049 i SJ19492048 a rhan o lwybr troed 15 sy'n rhedeg o SJ19372076 i SJ19242070 i SJ19092066 hyd at linell sy'n rhedeg o SJ19342074 i SJ19242070 i SJ19092066 fel y dangosir ar fap y Gorchymyn.

The effect of the Order as confirmed is to divert parts of footpath 14 running from SJ19172093 to SJ19302087 to a line running from SJ19172093 on a line that abuts alongside the drainage ditch to SJ19302087 and from SJ19302086 to SJ19372076 to SJ19402069 to a line running from SJ19302086 to SJ19342074 to SJ19402069 and from SJ19482049 to SJ19492048 to a line running from SJ19482049 to SJ19492049 to SJ19492048 and part of footpath 15 running from SJ19372076 to SJ19242070 to SJ19092066 to a line running from SJ19342074 to SJ19242070 to SJ19092066 as shown on the Order map.

Daw'r Gorchymyn i rym ar 26 Awst 2010. Os oes rhywun y mae'r Gorchymyn yn ei dramgwyddo am holi ynghylch ei ddilysrwydd, neu ddilysrwydd unrhyw ddarpariaeth sydd ynddo, ar y sail nad yw o fewn grymoedd Deddf Prifffyrdd 1980, fel y'i diwygiwyd, neu ar y sail na chydymffurfwyd ag un o ofynion y Ddeddf, fel y'i diwygiwyd, neu â rheoliad a wnaed dan y Ddeddf o ran y Gorchymyn, gall ef neu hi wneud cas (dan baragraff 2 Atodlen 2 y Ddeddf, fel y'i cymhwysir i baragraff 5 Atodlen 6 y Ddeddf) i'r Uchel Lys cyn pen chwech wythnos o 16 Awst 2010.

The Order comes into force on 26 August 2010 but if a person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under paragraph 2 of Schedule 2 of the Act as applied by paragraph 5 of Schedule 6 of the Act, within six weeks from 16 August 2010 make an application to the High Court.
