Mae Cynghor Sir Ddinbych yn bwriadu yn ddim hwyrach na 7 diwrnod o Fedi 30ain 2010 gwneud Gorchymyn a fydd yn gwahardd unrhyw gerbyd rhag defnyddio'r hyd hwnnw o Coppy Road Dinbych, yn Sir Ddinbych, sy'n ymestyn o'i chyffordd â Than y Sgubor i gyfeiriad y gogledd orllewin am bellter o oddeutu 225 metr.

Y rheswm am y cau yw hwyluso gwaith draenio gan McPhilips.

Y llwybr gwahanol sydd ar gael i draffig fydd drwy Stryd Henllan, Barkers Well, Ffordd y Graig, Plas Chambers Road, Graig Road, B45429 a B5382 a bydd wedi ei gyfeirbwyntio felly. Fe gynhelir mynediad i gerddwyr drwy gydol cyfnod y cau.

Daw'r Gorchymyn i rym ar ddydd Iau Hydref 21ain, 2010 a bydd yn dal mewn grym am gyfnod o ddeunaw mis neu hyd gwblhau'r gwaith pa un bynnag yw'r cynharaf. Rhagwelir y bydd y gwaith yn cymryd oddeutu 4 wythnos i'w gwblhau.

NOTICE OF TEMPORARY PROHIBITION OF THROUGH TRAFFIC ORDER

ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14

Denbighshire County Council intends not sooner than 7 days from 30th September 2010 to make an Order which will prohibit any vehicle from using that length of Coppy Road Denbigh, in the County of Denbigh, which extends from its junction with Tan y Sgubor in a north westerly direction for a distance of approximately 225 metres.

The reason for the closure is to facilitate drainage works by McPhilips.

The alternative route available for traffic will be via, Henllan Street, Barkers Well, Ffordd y Graig, Plas Chambers Road, Graig Road, B45429 and B5382 and will be sign posted accordingly. Pedestrian access will be maintained throughout the period of closure.

The Order will come into force on Thursday 21st October, 2010 and remain in force for a period of eighteen months or until the completion of the works whichever is the earlier. It is anticipated that the works will take approximately 4 weeks to complete.
