**Notice of Confirmation
of a Public Path Order
The Highways Act 1980**

Gorchymyn Gwyo Llwybr Cyhoeddus (Gwyo rhan o Gilffordd Gyfyngedig 30 yng Nghymuned Llanfechain) Cyngor Sir Powys 2010

Ar 5 Tachwedd 2010 fe gadarnhaodd Cyngor Sir Powys y Gorchymyn uchod a wnaed dan Adran 119 Deddf Prifffyrdd 1980.

Effaith y Gorchymyn, fel y'i cadarnhawyd, yw gwyo'r gilffordd gyfyngedig sy'n rhedeg o SJ1701,2085 i SJ1695,2088 hyd at linell sy'n rhedeg o SJ1701,2085 i SJ1698,2084 i SJ1697,2085 i SJ1697,2087 i SJ1695,2088 fel y dangosir ar fap y Gorchymyn.

The Powys County Council (Diversion of part of Restricted Byway 30 in the Community of Llanfechain) Public Path Diversion Order 2010

On 5 November 2010 Powys County Council confirmed the above Order made under Section 119 of the Highways Act 1980.

The effect of the Order as confirmed is to divert the restricted byway running from SJ1701,2085 to SJ1695,2088 to a line running from SJ1701,2085 to SJ1698,2084 to SJ1697,2085 to SJ1697,2087 to SJ1695,2088 as shown on the Order map.

A copy of the Order as confirmed and the Order map have been placed and may be seen free of charge at Head of Legal Services Powys County Council Neuadd Maldwyn Severn Road Welshpool Powys during normal office hours. Copies of the Order and Order Map may be purchased there at a price of 10 pence per sheet.

The Order comes into force on 4 December 2010 but if a person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under paragraph 2 of Schedule 2 of the Act as applied by paragraph 5 of Schedule 6 of the Act, within six weeks from 26 November 2010 make an application to the High Court.
