- 1. Gorchymyn (A4081 North Avenue, Llandrindod) (Gwaharddiad Aros) 2010**  
Yr ochr ogleddol o'i chyffordd â'r A4081 cylchfan Heol Brookland am bellter o 46m i gyfeiriad y gorllewin. Yr ochr ddeheuol o'i chyffordd â'r U1653 Ffordd Cadwallader am bellter o 48.5m i gyfeiriad y gorllewin.
- 2. Gorchymyn (Mynedfa'r Ganolfan Ieuencid, Llandrindod) (Gwaharddiad Aros) 2010**  
Y ddwy ochr ar gyfer yr hyd gyfan o'i chyffordd â'r U1653 Ffordd Cadwallader.

Powys County Council has made the above Orders under Sections 1(1), 2(1) and 4(2) of the Road Traffic Regulation Act 1984 to introduce prohibition of waiting at any time at:

- 1. A4081 North Avenue, Llandrindod Wells) (Prohibition of Waiting) Order 2010**  
North side from its junction with the A4081 Brookland Road roundabout for a distance of 46m in a westerly direction. South side from its junction with U1653 Cadwallader Way for a distance of 48.5m in a westerly direction.
- 2. (Youth Centre Access, Llandrindod Wells) (Prohibition of Waiting) Order 2010**  
Both sides for the whole of its length from its junction with the U1653 Cadwallader Way.

Full details of the Order with the Council's reasons may be examined at County Hall, Llandrindod Wells. If you wish to question the validity of the Order, you may within six weeks from 26 November 2010 apply to the High Court.
