PUBLIC FOOTPATH NO. 66 LLANTYSILIO, LLANGOLLEN
NOTICE OF TEMPORARY PROHIBITION OF PEDESTRIANS ORDER
ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14**

Denbighshire County Council has made an Order which prohibits any pedestrian from using Public Footpath No. 66 in the Community of Llantysilio at Pentrefelin near Llangollen, in the County of Denbigh adjacent to the canal towpath between the access bridge to the Chain Bridge Hotel and the access bridge to Llangollen Motor Museum.

The reason for the closure is to facilitate repairs to the canal liner and embankment by British Waterways

There are no alternative routes available. Pedestrian access through the closed section cannot be maintained throughout the period of closure. However access will be maintained to the Chain Bridge Hotel and to Llangollen Motor Museum.

The Order comes into force on 1 November 2010, and will remain in force for a period of six months or until the completion of the works whichever is the earlier. It is anticipated that the works will take approximately 8 weeks to complete

Mae Cynghor Sir Ddinbych wedi gwneud Gorchymyn a fydd yn gwahardd unrhyw gerddwyr rhag defnyddio Llwybr Cyhoeddus rhif 66 yng Nghymuned Llandysilio ym Mhentrefelin ger Llangollen, yn Sir Ddinbych sy'n gyfagos â llwybr tynnu'r gamlas rhwng y bont fynediad i Westy'r Chain Bridge a'r bont fynediad i Amgueddfa Foduron Llangollen.

Y rheswm am y cau yw hwyluso atgyweiriadau i leiner y gamlas a'r arglawdd gan British Waterways.

Nid oes yna lwybrau gwahanol ar gael. Ni ellir cynnal mynediad i gerddwyr ar hyd y rhan sydd wedi cau drwy gydol cyfnod y cau. Ond fe gynhelir mynediad i Westy'r Chain Bridge ac i Amgueddfa Foduron Llangollen.

Fe ddaw'r Gorchymyn i rym ar Dachwedd 1 2010 a bydd yn dal mewn grym am gyfnod o chwe mis neu hyd gwblhau'r gwaith pa un bynnag yw'r cynharaf. Rhagwelir y bydd y gwaith yn cymryd oddeutu 8 wythnos i'w gwblhau.
