**ROAD TRAFFIC REGULATION ACT 1984  
SECTION 14(1) AS AMENDED BY THE ROAD TRAFFIC  
(TEMPORARY RESTRICTIONS) ACT 1991**

**THE GWYNEDD COUNCIL  
(THE HIGH STREET AND THE UNCLASSIFIED ROAD NEAR TO THE  
TOWN CLOCK, BANGOR)  
(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2010**

**NOTICE IS HEREBY GIVEN** that the Gwynedd Council have made an Order, the effect of which is to prohibit any person from causing any vehicle to proceed in either direction along those lengths of roads known as:-

1. The unclassified road known as the High Street, Bangor from its junction with Dean Street in a south westerly direction to its junction with the road known as Glanrafon, Bangor.
2. The unclassified road near to the Town Clock, Bangor from a point which joins with the road known as the High Street in a westerly direction to its junction which joins with Garth Road/Tan y Fynwent, Bangor.

The Order is necessary to enable works relating to the City Centre Improvement Scheme.

The Order comes into effect on the 10th January, 2011 and will continue in force for a period not exceeding eighteen months or until the work which it is proposed to carry out on the road is completed, whichever is the earlier. At this stage it is anticipated that the work will be completed within approximately 10 months.
