

Y Ddeddf Priffyrdd 1980

**Gorchymyn Gwyro Llwybr
Cyhoeddus Cyngor Sir Powys
(Gwyro rhannau o Lwybr Troed 24

Ar 16 Tachwedd 2011 cadarnhaodd Cyngor Sir Powys y Gorchymyn uchod a wnaed dan Adran 119 y Ddeddf Priffyrdd 1980. Effaith y Gorchymyn fel y'i cadarnhawyd yw gwyro'r llwybr troed ym Mronhaul Issa, Bwlch-y-ddar yn rhedeg o (a) SJ1680,2191 i SJ1685,2193 hyd at SJ1687,2190 i linell sy'n rhedeg o SJ1680,2191 i SJ1681,2191 i SJ1685,2190 i SJ1687,2190 a (b) yn rhedeg o SJ1685,2193 i SJ1684,2195 hyd at linell sy'n rhedeg o SJ1687,2190 i SJ1688,2192 i SJ1688,2193 i SJ1687,2196 fel y'i dangosir ar fap y Gorchymyn.

The Highways Act 1980

**The Powys County Council (Diversion
of parts of Public Footpath 24 in the
Community of Llanfechain) Public
Path Diversion Order 2011**

On 16 November 2011 Powys County Council confirmed the above Order made under Section 119 of the Highways Act 1980. The effect of the Order as confirmed is to divert the footpath at Bronhaul Issa, Bwlch-y-ddar running from (a) SJ1680,2191 to SJ1685,2193 to SJ1687,2190 to a line running from SJ1680,2191 to SJ1681,2191 to SJ1685,2190 to SJ1687,2190 and (b) running from SJ1685,2193 to SJ1684,2195 to a line running from SJ1687,2190 to SJ1688,2192 to SJ1688,2193 to SJ1687,2196 as shown on the Order map.

A copy of the Order as confirmed and the Order map have been placed and may be seen free of charge at Powys County Council Offices at Neuadd Maldwyn, Severn Road, Welshpool SY21 7AS during normal office hours. Copies of the Order and Order Map may be purchased there at a price of 10 pence per sheet.

The Order comes into force on 15 December 2011 but if a person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under paragraph 2 of Schedule 2 of the Act as applied by paragraph 5 of Schedule 6 of the Act, within six weeks from 29 November 2011 make an application to the High Court.
