**The Powys County Council (Extinguishment
of parts of Public Footpath 1 and 2 in the
Community of Llandrinio) Public Path
Extinguishment Order 2012:**

On 12 July 2012 Powys County Council confirmed the above Order made under Section 118 of the Highways Act 1980. The effect of the Order as confirmed is to extinguish part of footpath 1 running from SJ3245,1614 to SJ3270,1594 to SJ3275,1617 and part of footpath 2 running from SJ3270,1594 to SJ3267,1613 as shown on the Order map.

**The Powys County Council (Creation of
Public Footpath 1(A) in the Community
of Llandrinio) Public Path Creation
Order 2012:**

On 12 July 2012 Powys County Council confirmed the above Order made under Section 26 of the Highways Act 1980.

The effect of the Order as confirmed is to create a footpath at The Haim running from SJ3245,1614 to SJ3261,1613 to SJ3267,1613 to SJ3275,16 as shown on the Order map.

A copy of the Orders as confirmed and the Order maps have been placed and may be seen free of charge at Powys County Council, Customer Service Point, Neuadd Maldwyn, Severn Road, Welshpool, Powys during normal office hours. Copies of the Orders and Order Maps may be purchased there at a price of 10 pence per sheet.

The Orders come into force on 10 August 2012 but if a person aggrieved by the Orders wants to question their validity, or that of any provision contained in them, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Orders, he or she may, under paragraph 2 of Schedule 2 of the Act as applied by paragraph 5 of Schedule 6 of the Act, within six weeks from 28 July 2012 make an application to the High Court.
