The above Order was made on the 17 December 2012. The effect of the Order will be to divert the footpath at Boxtree Cottage running from SJ1352,0110 to SJ1359,0120 to a line running from SJ1352,0110 to SJ1353,0116 to SJ1356,0119 to SJ1359,0120 as shown on the Order map.

A copy of the Order and the Order map have been placed and may be seen free of charge at Powys County Council Offices, Neuadd Maldwyn, Severn Road, Welshpool, Powys during normal office hours. Copies of the Order and map may be purchased there at a price of 10p per sheet.

Any representations about or objections to the Order may be sent in writing to the Strategic Director – Law and Governance, Legal Services, Powys County Council, Neuadd Maldwyn, Severn Road, Welshpool, Powys not later than 4 February 2013 and the applicants are requested to state the grounds on which they are made.

If no such representations or objections are duly made, or if any so made are withdrawn, the Powys County Council may confirm the Order as an unopposed Order. If the Order is sent to the National Assembly for Wales for confirmation any representations or objections which have not been withdrawn will be sent with the Order.
