**Notice of Confirmation of a
Public Path Order
Town and Country Planning Act 1990
section 257**

The Powys County Council (Diversion
of part of public footpath 68 in the
Community of Bausley and Criggion)
Public Path Diversion Order 2012**

On the 1 February 2013 Powys County Council confirmed the above Order. The effect of the Order is to divert the footpath at The Malthouse running from SJ3411,1482 to SJ3416,1490 to a line running from SJ3413,1481 to SJ3414,1482 to SJ3416,1490 as shown on the Order map.

A copy of the Order and the Order map have been placed and may be seen free of charge at Powys County Council Offices at Neuadd Maldwyn, Severn Road, Welshpool, Powys during normal office hours. Copies of the Order and map may be purchased there at a price of 10p per sheet.

The Order comes into force on the 1 February 2013 but if any person aggrieved by the Order decides to question its validity or that of any provision contained in it on the ground that it is not within the powers of the above Act, or on the ground that any requirement of that Act or any regulation made under it has not been complied with in relation to the confirmation of the Order, he or she may apply to the High Court for any of these purposes under Section 287 of the Town & Country Planning Act 1990 within six weeks from the date on which notice is first published as required by paragraph 7 of Schedule 14 to that Act.
