Ar 16 Medi 2013 cadarnhaodd Cyngor Sir Powys y Gorchymyn uchod a wnaed dan Adran 119 Deddf Priffyrdd 1980. Effaith y Gorchymyn fel y'i cadarnhawyd yw gwro'r llwybr troed yng Nghallt yr Ancr sy'n rhedeg o SJ1411 1260 i SJ1452 1326 i linell sy'n rhedeg o SJ1412 1260 i SJ1419 1272 i SJ1428 1284 i SJ1426 1298 i SJ1428 1300 i SJ1452 1326 fel y'i gwelir ar fap y Gorchymyn.

On 16 September 2013 Powys County Council confirmed the above Order made under Section 119 of the Highways Act 1980. The effect of the Order as confirmed is to divert the footpath at Gallt yr Ancr running from SJ1411 1260 to SJ1452 1326 to a line running from SJ1412 1260 to SJ1419 1272 to SJ1428 1284 to SJ1426 1298 to SJ1428 1300 to SJ1452 1326 as shown on the Order map.

Gellir gweld copi o'r Gorchymyn fel y'i cadarnhawyd a map y Gorchymyn am ddim yn Swyddfeydd Cyngor Sir Powys yn Neuadd Maldwyn, Ffordd Hafren, Y Trallwng, SY21 7AS yn ystod oriau swyddfa arferol. Gellir prynu copïau o'r Gorchymyn a'r map yno am 10c y ddalen.

Daw'r Gorchymyn i rym ar 15 Hydref 2013. Os yw rhywun y mae'r Gorchymyn yn ei dramgwyddo am holi ynghylch ei ddilysrwydd, neu ddilysrwydd unrhyw ddarpariaeth ynddi, ar y sail nad yw o fewn pwerau Deddf Priffyrdd 1980, fel y'i diwygiwyd, neu ar y sail na chydymffurfiwyd ag un neu fwy o ofynion y Ddeddf yn y Gorchymyn, gall ef neu hi wneud cais i'r Uchel Lys cyn pen chwe wythnos o 5 Hydref 2013, dan baragraff 2 Atodlen 2 y Ddeddf fel y mae wedi'i gymhwyso gan baragraff 5 Atodlen 6 y Ddeddf.

The Order comes into force on 15 October 2013 but if a person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under paragraph 2 of Schedule 2 of the Act as applied by paragraph 5 of Schedule 6 of the Act, within six weeks from 5 October 2013 make an application to the High Court.
