The Orders come into force on 15 October 2013 but if a person aggrieved by the Orders wants to question its validity, or that of any provision contained in them, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Orders, he or she may, under paragraph 2 of Schedule 2 of the Act as applied by paragraph 5 of Schedule 6 of the Act, within six weeks from 5 October 2013 make an application to the High Court.
