

NOTICE OF CONFIRMATION OF AN ORDER HIGHWAYS ACT 1980

THE FLINTSHIRE COUNTY COUNCIL (PUBLIC FOOTPATH NO. 13 IN THE COMMUNITY OF HALKYN) PUBLIC PATH EXTINGUISHMENT ORDER 2013

On 15th October 2013, the Flintshire County Council confirmed the above order made under Section 118 of the Highways Act 1980.

The effect of the order as confirmed is to:

extinguish a section of Public Footpath No. 13 in the Community of Halkyn in the County of Flintshire from a point at NGR 31964 37225 in a generally East-North-Easterly direction for a total distance of approximately 164 metres to a point at NGR 31977 37233 as indicated by a bold continuous line between points A and B on the Order map.

A copy of the confirmed Order and the Order Map have been placed and may be seen free of charge during opening hours at Pentre Halkyn Post Office, The Village, Pentre Halkyn, CH8 8HP and at reasonable hours at the Environment reception, Flintshire County Council, County Hall, Mold, Flintshire. Copies of the Order and map may be bought at County Hall for £5.00.

The order came into force on 15th October 2013, but if a person aggrieved by the order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from the date on which the notice is first published, make an application to the High Court.

NOTICE OF MODIFICATION ORDER SECTION 53 OF THE WILDLIFE AND COUNTRYSIDE ACT 1981

DEFINITIVE MAP AND STATEMENT OF PUBLIC RIGHTS OF WAY FOR THE COUNTY OF CLWYD THE FLINTSHIRE COUNTY COUNCIL PUBLIC FOOTPATH FROM LLYS BEN TO PUBLIC FOOTPATH NO. 16 IN THE COMMUNITY OF NORTHOP HALL (FORMERLY IN THE COMMUNITY OF NORTHOP)) DEFINITIVE MAP MODIFICATION ORDER 2013

The above Order made on the 15 October 2013, if confirmed as made, will modify the definitive map and statement for the area by adding to them a public footpath, that is a public right of way on foot, with a width of between 1.2 and 1.8 metres, in the Community of Northop Hall (formerly in the Community of Northop), in the County of Flintshire, from its junction with Llys Ben at NGR 32714 36789 initially in a North-North-Easterly, then in an East-South-Easterly and finally in an East-North-Easterly direction for a total distance of approximately 222 metres to connect with Public Footpath No. 16 at NGR 32733 36797, as indicated by a bold broken line between points A and B on the Order Map.

A copy of the Order and the Order Map may be seen free of charge during opening hours at Northop Hall Post Office, and at reasonable hours at the Environment reception, Flintshire County Council, County Hall, Mold, Flintshire. Copies of the Order and Map may be bought at County Hall for £5.00

Any representation or objection relating to the Order must be sent in writing to the Director of Environment at the address below (quoting reference RS/SJB/11/3/414) no later than 13 December, and must include particulars of the grounds relied on.

If no representations or objections are duly made to the Order, or if any so made are withdrawn, the Flintshire County Council, instead of submitting the Order to the Welsh Government, may itself confirm the Order. If the Order is submitted to the Welsh Government, any representations or objections which have been duly made and not withdrawn will be sent with it.
