

## **NOTICE OF TEMPORARY PROHIBITION OF THROUGH TRAFFIC ORDER ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14 LLOC**

Flintshire County Council has made an Order which prohibits any vehicle from using St. Asaph Road between its junctions with A5026 and Gorsedd Road, Lloc in the County of Flintshire.

During the period of the works the current One-Way restriction on St. Asaph Road will be suspended.

The reason for the closure is to facilitate water mains renewals with associated works by Dwr Cymru/Welsh Water. The alternative routes for vehicles will be signed accordingly by the use of prescribed signs. Pedestrian access will be maintained throughout the period of the closure.

The Order comes into force on the 6th January 2014. It is anticipated that the roads will only be closed for four weeks, or until the earlier completion of the works, subject to a maximum period of eighteen months.
