

**NOTICE OF CONFIRMATION  
OF AN ORDER  
SECTION 53 OF THE WILDLIFE  
AND COUNTRYSIDE ACT 1981  
DEFINITIVE MAP AND STATEMENT  
OF PUBLIC RIGHTS OF WAY FOR THE  
COUNTY OF CLWYD  
THE FLINTSHIRE COUNTY COUNCIL  
(PUBLIC FOOTPATH NO. 40 IN THE  
COMMUNITY OF YSCEIFIOG)  
DEFINITIVE MAP MODIFICATION  
ORDER 2013**

On 7th January 2014, Flintshire County Council confirmed the above Order without modification.

The effect of the Order as confirmed is to modify the definitive map for the area by:

- i) adding to the map a public footpath, that is a public right of way on foot, with a width of 2 metres throughout, in the Community of Ysceifiog, in the County of Flintshire, from a point at NGR 31638 37350, running in a North Easterly direction for a total distance of approximately 54 metres to its junction with Ffordd Babel at NGR 31641 37354, as indicated by a bold broken line between points A and C on the Order map.
- ii) deleting from the map that section of Public Footpath No. 40 in the Community of Ysceifiog, in the County of Flintshire, running from a point at NGR 31638 37350 and curving initially in a South Easterly and then in an East-South-Easterly and finally in an East-North-Easterly direction for a total distance of approximately 115 metres to a point at NGR 31648 37346, as indicated by a bold continuous line between points A and B on the Order map.
- iii) varying particulars contained in the statement

A copy of the confirmed Order and the Order Map may be seen free of charge during opening hours at Pentre Halkyn Post Office and at reasonable hours at the Environment reception, Flintshire County Council, County Hall, Mold, Flintshire. Copies of the Order and map may be bought at County Hall for £5.00.

This Order came into force on 7th January 2014, but if any person aggrieved by the Order desires to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the above Act, or on the ground that any requirement of that Act or any regulation made under it has not been complied with in relation to the confirmation of the order, he or she may apply, under Schedule 15 to the Wildlife and Countryside 1981, as applied by paragraph 12 of that Schedule, to the High Court within 42 days from the date upon which Notice is first published as required by paragraph 11 of Schedule 15 to the Act.

Ar 7fed Ionawr 2014, cadarnhaodd Cyngor Sir y Fflint y Gorchymyn uchod heb ei addasu.

Effaith y Gorchymyn fel y'i cadarnhawyd yw addasu'r map diffiniol ar gyfer yr ardal tramw:

- i) ychwanegu at y map lwybr troed cyhoeddus, hynny yw hawl tramwy cyhoeddus ar droed, gyda lled o 2 fetr drwyddo, yng Nghymuned Ysceifiog, yn Sir y Fflint, o bwynt yn NGR 31638 37350, yn rhedeg i gyfeiriad y Gogledd-Ddwyrain am gyfanswm o tua 54 metr i'w gyffordd â Ffordd Babel yn NGR 31641 37354, fel y dangosir gan linell doredig dywyll rhwng pwyntiau A ac C ar fap y Gorchymyn.
- ii) dileu o'r map y rhan honno o Lwybr Troed Cyhoeddus Rhif 40 yng Nghymuned Ysceifiog, yn Sir y Fflint, sy'n rhedeg o bwynt yn NGR 31638 37350 ac yn gwyrto i ddechrau i gyfeiriad y De-Ddwyrain ac yna i gyfeiriad y Dwyrain-De-Ddwyrain ac yn y diwedd i gyfeiriad y Dwyrain-Gogledd-Ddwyrain am gyfanswm o tua 115 metr i bwynt yn NGR 31648 37346, fel y dangosir gan linell ddi-dor dywyll rhwng pwyntiau A a B ar fap y Gorchymyn.

- iii) amrywioi fanylion a gynhwysir yn y datganiad

Gellir gweld copi o'r Gorchymyn a gadarnhawyd a Map y Gorchymyn yn rhad ac am ddim yn ystod oriau agor yn Swyddfa Bost Pentre Helygain ac yn ystod oriau rhesymol yn nerbynfia Cyfarwyddiaeth yr Amgylchedd, Cyngor Sir y Fflint, Neuadd y Sir, Yr Wyddgrug, Sir y Fflint. Gellir prynu copiau o'r Gorchymyn a'r map yn Neuadd y Sir am £5.00.

Daeth y Gorchymyn hwn i rym ar 7fed Ionawr 2014, ond os yw rhywun a dramgwyddwyd gan y Gorchymyn yn dymuno cwestiynu ei ddilysrwydd, neu unrhyw ddarpariaeth a gynhwysir ynddo, am y rheswm nad yw o fewn pwerau'r Ddeddf uchod, neu am y rheswm na chydymffurfiwyd ag unrhyw un o ofnyon y Ddeddf honno neu ag unrhyw reoliad a wnaed o dan y Ddeddf mewn perthynas â chadarnhau'r gorchymyn, gall ef neu hi, o dan Atodlen 15 i Ddeddf Bywyd Gwyllt a Chefn Gwlad 1981, fel y'i cymhwysir gan baragraff 12 yr Atodlen honno, wneud cais i'r Uchel Lys o fewn 42 diwrnod i'r dyddiad y caiff yr Hysbysiad ei gyhoeddi gyntaf fel y mynnir gan baragraff 11 Atodlen 15 i'r Ddeddf.
