The council has made The County Borough of Wrexham (Various Locations) (20 MPH Zone) Order 2014 effective from 15.9.14 the Order will prohibit any vehicle driving above 20mph on the following lengths of road:

(Road Affected, Length Affected): School Lane, Overton from St Mary's Avenue northerly to Turning Street: Old School Mews

Its entire length: School Street, Rhostyllen from Church Street north easterly to Trinity Street: School Mews, Rhostyllen, Its entire length: Brynteg Crescent, Brynteg, Its entire length, Maesteg, Brynteg, Its entire length: Claypit Lane, Marford From 20m north east of junc with Meadows View north easterly direction to its junc with Wynnstay Lane:

Wynnstay Lane, Marford, from 63m west of its junc with Stancliffe Ave westerly to its junc with Claypit Lane.

Full details may be examined at Abbey Road Depot, Abbey Road South, Wrexham Industrial Estate during normal office hours.

If you believe this Order is invalid because it does not comply with the legal requirements, you can apply to the High Court 6 weeks from 19.9.14.
