**Notice of Confirmation of  
a Public Path Order  
Highways Act 1980**

On 5th August 2014 Powys County Council confirmed the above Order made under Section 119 of the Highways Act 1980.

The effect of the Order as confirmed is to divert the footpath at Sarn Farm running from SN9541 9772 to SN9534 9765 to a line running from SN9539 9774 to SN9536 9775 to SN9535 9773 to SN9530 9769 to SN9532 9732 to SN9535 9766 to SN9534 9765 as shown on the Order map.

A copy of the Order as confirmed and the Order map have been placed and may be seen free of charge at Powys County Council Offices at The Customer Service Point, Back Lane, Newtown SY16 2NZ during normal office hours. Copies of the Order and Order Map may be purchased there at a price of 10 pence per sheet.

The Order comes into force on 2nd September 2014 but if a person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under paragraph 2 of Schedule 2 of the Act as applied by paragraph 5 of Schedule 6 of the Act, within six weeks from 26th September 2014 make an application to the High Court.
