Notice Under Section 12(6) of the Local Government Finance Act, 1992

At the full Council meeting held on the 22nd October 2014, it was resolved as follows:

“that for the financial year 2015-16, in accordance with Section 12 Local Government Finance 1992 (as amended) and The Council Tax (prescribed Classes of Dwellings) (Wales) (Amendment) Regulations 2004 the discount for Prescribed Class C – a chargeable dwelling that is unoccupied and substantially unfurnished shall not apply”

“that this decision shall remain effective each financial year unless rescinded”.

Explanatory Note

The Council Tax legislation allows for Welsh Local Authorities the discretion to determine the level of discount in respect of a certain class of dwellings. The dwellings falling into this class are unoccupied and substantially unfurnished. The Council has decided to grant no discount on these properties.
