MAE GWEINIDOGION CYMRU wedi gwneud Gorchymyn o dan adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn oherwydd perygl tebygol i'r cyhoedd ar gefnffordd yr A494 ym Mhont Afon Dyfrdwy, Queensferry, Sir y Fflint.

Disgwylir y daw'r cyfyngiad, y codir arwyddion priodol am ei hyd a'i led, i rym am 00:01 o'r gloch ar 1 Rhagfyr 2014 ac y bydd yn parhau mewn grym am gyfnod o 18 mis ar y mwyaf.

Effaith y Gorchymyn yw gosod terfyn cyflymder o 50 mya dros dro ar hyd darn o gerbytfordd tua'r gogledd yr A494 sy'n ymestyn o bwynt 325 o fetrau i'r gogledd o ganolbwynt Cyfnewidfa Queensferry hyd at bwynt 1,170 o fetrau i'r gogledd o ganolbwynt y cyfryw Gyfnewidfa.

**THE A494 TRUNK ROAD (DEE
BRIDGE, QUEENSFERRY, FLINTSHIRE)
(TEMPORARY 50 MPH SPEED LIMIT)
ORDER 2014**

THE WELSH MINISTERS have made an Order under section 14 of the Road Traffic Regulation Act 1984 which is necessary due to the likelihood of danger to the public on the A494 trunk road at the Dee Bridge, Queensferry, Flintshire.

The restriction, the extent of which will be signed accordingly, is expected to come into force at 00:01 hours on 1 December 2014 and remain in force for a maximum duration of 18 months.

The effect of the Order is to impose temporarily a 50 mph speed limit on the length of the northbound carriageway of the A494 that extends from a point 325 metres north of the centre-point of Queensferry Interchange to a point 1,170 metres north of the centre-point of the said Interchange.
