**Notice of Confirmation
of a Public Path Order
Highways Act 1980**

Powys County Council

**The Powys County Council (Diversion
of Public Bridleway no 44 (parts) in
the Community of Cadfarch) Public
Path Diversion Order 2014**

On 26th February 2015 Powys County Council confirmed the above Order made under Section 119 of the Highways Act 1980.

The effect of the Order as confirmed is to divert the bridleway at Glaslyn running from SN 8305 9396 to SN 8317 9343, via SN 8305 9355, to a line running from SN 8286 9365 to SN 8289 9355 and then to SN 8317 9343 and running from SN 8372 9304 to SN 8385 9306 to a line running from SN 8372 9304 to SN 8373 9305 to SN 8378 9305 to SN 8381 9302 to SN 8384 9306 and then to SN 8385 9306 as indicated on the plans attached to the Order.

A copy of the Order as confirmed and the Order map have been placed and may be seen free of charge at Powys County Council Machynlleth Library, Maengwyn Street, Machynlleth, Powys SY20 8DY during normal office hours. Copies of the Order and Order Map may be purchased there at a price of 10 pence per sheet.

The Order comes into force after 28 days from the date on which Powys County Council certifies the works have been completed to bring the highway into a fit condition for use by the public but if a person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under paragraph 2 of Schedule 2 of the Act as applied by paragraph 5 of Schedule 6 of the Act, within six weeks from 13th March 2015 make an application to the High Court.
