Mae Cyngor Sir Ddinbych yn bwriadu gwneud Gorchymyn, dim cynt na 7 niwrnod o 1 Ebrill 2015, yn gwahardd cerbydau rhag defnyddio'r lôn o'r A539 i'r gyffordd gyferbyn â Trevor Mill House, Trefor, yn Sir Ddinbych am ei hyd cyfan. Mae angen cau er mwyn adnewyddu'r brif bibell ddŵr gan Ddŵr Dyffryn Dyfrdwy.

Bydd y llwybr amgen i draffig, gydag arwyddion, ar hyd Bryn Howell Road o'r A539 i Ffarm Plas yn Pentre, A539. Bydd mynediad i gerddwyr trwy gydol y cyfnod cau.

Daw'r Gorchymyn i rym ar 20 Ebrill 2015, a bydd yn parhau mewn grym am gyfnod o ddeunaw mis neu hyd nes y cwblheir y gwaith, pa un bynnag sydd gynharaf. Disgwylir i'r gwaith gymryd oddeutu 5 niwrnod i'w gwblhau.

NOTICE OF TEMPORARY PROHIBITION OF THROUGH TRAFFIC ORDER

ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14

Denbighshire County Council intends not sooner than 7 days from 1st April 2015 to make an Order prohibiting vehicles from using the lane from A539 to the junction opposite Trevor Mill House, Trevor, in the County of Denbigh for its entire length. The closure is necessary to facilitate water main renewals by Dee Valley Water.

The signposted alternative route for traffic will be via Bryn Howell Road from A539 to Plas yn Pentre Farm, A539. Pedestrian access will be maintained throughout the period of closure.

The Order will come into force on 20th April 2015 and remain in force for a period of eighteen months or until the completion of the works whichever is the earlier. It is anticipated that the works will take approximately 5 days to complete.
