Rhoddir rhybudd drwy hyn bod Cyngor Sir Powys wedi gwneud Gorchymyn i ddiwygio Gorchymyn Sir Powys (Sir Drefaldwyn) Ffordd y B4393 rhwng Llandysilio a Choedway) (Cyfyngiadau cyflymder 30 MYA a 50 MYA) 2005 dan Adran 84(1) a (2) Deddf Rheoli Traffig y Ffyrdd 1984.

Bydd y Gorchymyn diwygiedig a ddaw i rym ddydd Llun 11 Mai 2015 yn ei gwneud yn anghyfreithlon i yrru cerbyd ar gyflymder dros drideg milltir yr awr ar hyd y rhan honno o ffordd y B4393 ym Mhont Llandrinio yng nghymuned Llandrinio sy'n ymestyn o fan oddeutu 150 metr i'r gogledd-orllewin o'i chyffordd â'r C2038 ym Mhont Llandrinio am bellter o tua 400 metr i gyfeiriad y de-ddwyrain.

(Amendment No. 1) Order 2015

Notice is hereby given that Powys County Council has made an Order to modify The County of Powys (Montgomeryshire) (B4393 Road between Four Crosses and Coedway) (30 MPH and 50 MPH Speed Limits) Order 2005 under Section 84(1) and (2) of the Road Traffic Regulation Act, 1984.

The modified Order which comes into effect on Monday 11th May 2015 will make it unlawful to drive a vehicle at a speed exceeding thirty miles per hour in that length of the B4393 road at Llandrinio Bridge in the community of Llandrinio which extends from a point approximately 150 metres north-west of its junction with the C2038 at Llandrinio Bridge for a distance of approximately 400 metres in a south-easterly direction.

If you wish to question the validity of this Order, you may within 6 weeks from 11th May 2015 apply to the High Court for this purpose.
