

**The County Borough of Wrexham (Watery Road, Wrexham) (Prohibition of Waiting) Order 2014**

Notice is hereby given that on the 24.06.15 the Wrexham County Borough Council made the above named Order the effect of which is to prohibit the waiting of vehicles in Watery Road, Wrexham, from 37m west of Bradley Road westerly for 55m on the southern side.

Exemptions are provided in the Order to permit waiting for the purposes of alighting, boarding, loading, unloading and works of maintenance, repair and the like.

Exemptions are also provided in the Order to allow vehicles displaying both a disabled person's badge wait at any time in the length of road specified for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle on the same day).

If you believe this Order is invalid because it does not comply with the legal requirements you can apply to the High Court 6 weeks from 26.06.15, Full details may be examined at Abbey Road Depot, Abbey Road South, Wrexham Industrial Estate during normal office hours.

**Gorchymyn (Ffordd Ddyfrllyd) (Gwahardd Aros) Bwrdeistref Sirol Wrecsam 2015**

Rhoddir rhybudd trwy hyn bod y Cyngor wedi gwneud Gorchymyn uchod ar 24.06.15, a'i effaith yw gwahardd cerbydau rhag aros ar Ffordd Ddyfrllyd, Wrecsam, o bwynt 37 metr i'r gorllewin o Ffordd Bradle i'r gorllewin am bellter o 55m ar yr ochr ddeheuol. Darperir eithriadau yn y Gorchymyn i ganiatáu aros at ddibenion disgyn, doddi, llwytho, dadlwytho a gwaith cynnal a chadw, atgyweirio ac ati.

Mae eithriadau hefyd wedi eu darparu yn y Gorchymyn i ganiatáu i gerbydau sy'n arddangos bathodyn person anabl i aros ar unrhyw adeg ar y darn o ffordd a nodir yn yr Atodlen dan sylw am gyfnod o ddim mwy na tair awr (nad yw'n gyfnod a gairff ei wahanu gan gyfnod o lai nag un awr o gyfnod aros blaenorol gan yr un cerbyd ar yr un diwrnod).
