- 1) **Llys i Glyn Road Llanrhaeadr**, o'r gyffordd gydag Ystrad Road i'r gyffordd gyda Hen Efail i Llanrhaeadr.

Ffordd amgen: Trwy gyffordd Hen Efail i gyffordd Bryn Rossa, Bryn Rossa Road i Prion Road, a Llys i gyffordd Bryn Rossa Rd.

- 2) **Hen Efail i Lanrhaeadr**; o'r gyffordd gyda Llys i Glyn Road i'r gyffordd gyda Llanrhaeadr i Graig Llwyd.

Ffordd amgen: Trwy Llanrhaeadr i Graig Llwyd, Bryn Rossa Road, Graig Llwyd, cyffordd Hen Efail i gyffordd Bryn Rossa.

Dyddiedig: 12 Awst 2015.

NOTICE OF TEMPORARY PROHIBITION OF THROUGH TRAFFIC ORDER
ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14**

Denbighshire County Council has made an Order which prohibits any vehicle from using the lengths of roads referred to in the Schedule below. The reason for the closure is to facilitate BT works by A Plant Lux.

The alternative route available for traffic will be as stated in the Schedule and will be sign posted accordingly. Pedestrian access will be maintained throughout the period of closure.

The Order comes into force on 20th August 2015, for an eighteen month period or the earlier completion of the works whichever is soonest. It is anticipated that the works will take 2 weeks to complete.

Schedule

Lengths of road at Llanrhaeadr in the County of Denbigh

- 1) **Llys to Glyn road Llanrhaeadr**; from its junction with Ystrad Road to its junction with Hen Efail to Llanrhaeadr.

Alternative: via Hen Efail junction to Bryn Rossa junction, Bryn Rossa road to Prion road, and Llys to Bryn Rossa Rd junction.

- 2) **Hen Efail to Llanrhaeadr**; from its junction with Llys to Glyn road to its junction with Llanrhaeadr to Graig Llwyd.

Alternative: via Llanrhaeadr to Graig Llwyd, Bryn Rossa Road, Graig Llwyd, and Hen Efail junction to Bryn Rossa junction.
