**Notice of Confirmation
of a Public Path Order

**The Powys County Council (Diversion of part
of Public Footpath NL145 in the Community of
Nantmel) Public Path Diversion Order 2015**

On 27th August 2015 Powys County Council confirmed the above Order made under Section 257 of the Town and Country Planning Act 1990.

The effect of the Order as confirmed is to divert the footpath at Dolfyr Farm, Nantmel running from SN 9974,6901 to SN 9969,6921 to SN 9968,6923 to a line running from SN 9974,6901 to SN 9971,6904 to SN 9966,6908 to SN 9965,6912 to SN 9968,6920 and then to SN 9968,6923 as shown on the Order map.

A copy of the Order and the Order map have been placed and may be seen free of charge at Powys County Council Offices at The Gwalia, Ithon Road, Llandrindod Wells, LD1 6AA during normal office hours. Copies of the Order and map may be purchased there at a price of 10p per sheet.

The Order comes into force on the date on which Powys County Council certify that the terms of Article 2 of the order have been complied with but if any person aggrieved by the Order decides to question its validity or that of any provision contained in it on the ground that it is not within the powers of the above Act, or on the ground that any requirement of that Act or any regulation made under it has not been complied with in relation to the confirmation of the Order, he or she may apply to the High Court for any of these purposes under Section 287 of the Town & Country Planning Act 1990 within six weeks from the date on which notice is first published as required by paragraph 7 of Schedule 14 to that Act.
