**THE COUNTY BOROUGH OF CONWY (A548 FORYD
ROAD KINMEL BAY) (PROHIBITION OF RIGHT
TURN) ORDER 2009**

On 23 July 2009 the Conwy County Borough Council made the above-named Order under Sections 1 to 3 of the Road Traffic Regulation Act 1984, the effect of which is to prohibit any motor vehicle proceeding in the length of road specified in the Schedule hereto to make a right turn at the junctions specified in the said Schedule.

A copy of the Order, which will come into operation on 1 September 2009, and a map showing the length of road to which the Order relates may be examined at the offices of the Head of Legal & Democratic Services, Bodlondeb, Conwy LL32 8DU during normal office hours.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, you may, within six weeks from the date hereof apply to the High Court for this purpose.

**Length of road in Kinmel Bay in the County Borough
of Conwy**

A548 Foryd Road at its junction with Crugan Avenue and its north-eastern junction with The Square

1. No right turn into Crugan Avenue for vehicles travelling in a northerly direction on Foryd Road
2. No right turn into The Square for vehicles travelling in a southerly direction on Foryd Road
