Mae Cyngor Sir Ddinbych yn bwriadu gwneud Gorchymyn, ddim llai na 7 diwrnod o 16 Medi 2015 i wneud Gorchymyn yn gwahardd cerbydau sy'n defnyddio'r ffordd ddi-ddosbarth o'r enw Old House Farm i gyffordd Derwen Llannerch, Pentrecelyn Sir Ddinbych ar ei hyd gyfan. Mae angen cau'r ffordd er mwyn galluogi Gallagher Construction i osod dwythell BT.

Y llwybr amgen wedi'i arwyddo fydd drwy Ffordd Llidiart Fawr o Llidiart Fawr i Bryn Gwyn, Coleg Llysfasi i gyffordd Berth, A525 a B5429. Bydd mynediad i gerddwyr trwy gydol y cyfnod cau.

Daw'r Gorchymyn i rym ar 5 Hydref 2015 a bydd yn parhau mewn grym am gyfnod o ddeunaw mis neu hyd nes y cwblheir y gwaith yn gynt, pa un bynnag sydd gynharaf. Disgwylir i'r gwaith gymryd oddeutu 9 diwrnod i'w gwblhau.

NOTICE OF TEMPORARY PROHIBITION OF THROUGH TRAFFIC ORDER  
ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14**

Denbighshire County Council intends not sooner than 7 days from 16th September 2015 to make an Order prohibiting vehicles using the unclassified road known as Old Farm House to Derwen Llannerch junction, Pentrecelyn Denbighshire for its entire length. The closure is necessary to facilitate installation of a BT duct by Gallagher Construction.

The signposted alternative route will be via Llidiart Fawr Road from Llidiart Fawr to Bryn Gwyn, Llysfasi College to Berth junction, A525 and B5429. Pedestrian access will be maintained throughout the period of closure.

The Order comes into force on 5th October 2015 for an eighteen month period or the earlier completion of the works whichever is soonest. It is anticipated that the works will last approximately 9 days.
