Mae Cyngor Sir Ddinbych yn bwriadu gwneud Gorchymyn, ddim cynharach na 7 diwrnod o 23 Medi, 2015, yn gwahardd cerbydau rhag defnyddio Pen y Bryn Hill Corwen yn Sir Ddinbych yn ymestyn o'i chyffordd â'r B4401 i'w chyffordd â Hill Street. Mae angen cau'r ffordd er mwyn galluogi Gallagher Construction i osod dwythell BT.

Bydd y llwybr amgen gyda'r arwyddion ar hyd y B4401, A5 a Hill Street. Bydd mynediad i gerddwyr ar gael drwy gydol y cyfnod cau.

Daw'r Gorchymyn i rym ar 14 Hydref 2015 a bydd yn parhau mewn grym am gyfnod o ddeunaw mis neu hyd nes y cwblheir y gwaith, pa un bynnag sydd gynharaf. Disgwylir i'r gwaith gymryd oddeutu 9 diwrnod i'w gwblhau.

**NOTICE OF TEMPORARY PROHIBITION OF THROUGH TRAFFIC ORDER**  
**ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14**

Denbighshire County Council intends not sooner than 7 days from 23rd September 2015 to make an Order prohibiting vehicles using Pen y Bryn Hill Corwen in the County of Denbigh extending from its junction with B4401 to its junction with Hill Street. The closure is necessary to facilitate installation of a BT duct by Gallagher Construction.

The signposted alternative route will be via B4401, A5 and Hill Street. Pedestrian access will be maintained throughout the period of closure.

The Order comes into force on 14th October 2015 for an eighteen month period or until the completion of the works whichever is soonest. It is anticipated that the works will last approximately 9 days.
