Denbighshire County Council intends not sooner than 7 days from 30th September 2015 to make an Order which will prohibit vehicles from waiting, loading and unloading at any time, on the length of road referred to in the Schedule below. The reason for the restriction is to facilitate the temporary use of West Kinmel Street car park as a temporary Ariva bus depot while works are ongoing at the main bus depot.

The following traffic regulation order currently in place will be appropriately suspended on a temporary basis during the period of temporary enforcement.

Denbighshire County Council (Prohibition and Restriction of Waiting and Street Parking Places) Consolidation Order 2004

The Order has a maximum duration of eighteen months comes into effect on 14th October, 2015 and will remain in force whilst the works are ongoing, estimated to be approximately 12 months.
