Mae Cyngor Sir Ddinbych wedi gwneud Gorchymyn, sy'n gwahardd unrhyw gerbyd rhag teithio ar hyd y darn hwnnw o'r B5429 ym Mhentrecelyn, Sir Ddinbych, sy'n ymestyn o gyffordd â'r A525 Llysfasi i'r gyffordd gyda'r ffordd sy'n rhedeg o'r Hen Ffermdy i Derwen Llannerch.

Mae angen cau'r ffordd er mwyn galluogi Gallagher Construction i osod dwythell BT. Bydd arwyddion yn nodi'r llwybrau eraill i draffig. Bydd mynediad i gerddwyr ar gael drwy gydol y cyfnod cau.

Daw'r Gorchymyn i rym ar 24 Hydref 2015 a bydd yn parhau mewn grym am gyfnod o ddeunaw mis neu tan y bydd y gwaith wedi ei gwblhau, pa un bynnag sydd gyntaf. Disgwylir i'r gwaith gymryd 9 niwrnod i'w gwblhau.

NOTICE OF TEMPORARY PROHIBITION OF THROUGH TRAFFIC ORDER
ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14**

Denbighshire County Council has made an Order which prohibits any vehicle from using that length of B5429 at Pentrecelyn in the County of Denbigh extending from A525 Llysfasi crossroads to the junction with the road which runs from Old Farmhouse to Derwen Llannerch.

The closure is necessary to facilitate installation of a BT duct by Gallagher Construction. The alternative route available for traffic will be as signposted. Pedestrian access will be maintained throughout the period of closure.

The Order comes into force on 24th October 2015, and will remain in force for a period of eighteen months or until the completion of the works whichever is the earlier. It is anticipated that the works will take 9 days to complete.
