Mae Cyngor Sir Ddinbych wedi gwneud Gorchymyn, sy'n gwahardd unrhyw gerbyd rhag teithio ar hyd Pont Rhuddlan, Ffordd yr Orsaf Rhuddlan yn Sir Ddinbych, am ei hyd gyfan. Mae angen cau'r ffordd er mwyn i Adran Pontydd Cyngor Sir Ddinbych atgyweirio'r bont.

Y llwybr amgen gydag arwyddion fydd heibio cylchfan A525 Morfa Lodge, ffordd osgoi A525 Rhuddlan, cylchfan A547 Bryn Cwnin, Ffordd y Rhyl a'r Stryd Fawr. Bydd mynediad i gerddwyr ar gael drwy gydol y cyfnod cau.

Daw'r Gorchymyn i rym ar 24 Hydref 2015 a bydd yn parhau mewn grym am gyfnod o ddeunaw mis neu hyd nes y cwblheir y gwaith, pa un bynnag sydd gynharaf. Disgwylir i'r gwaith gymryd oddeutu 10 diwrnod i'w gwblhau.

NOTICE OF TEMPORARY PROHIBITION OF THROUGH TRAFFIC ORDER
ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14**

Denbighshire County Council has made an Order prohibiting vehicles using Rhuddlan Bridge, Station Road Rhuddlan in the County of Denbigh for its entire length. The closure is necessary to facilitate bridge works by Denbighshire County Council – Bridges Section.

The signposted alternative route will be via A525 Morfa Lodge roundabout, A525 Rhuddlan by pass, Bryn Cwnin roundabout A547, Rhyl Road and High Street. Pedestrian access will be maintained throughout the period of closure.

The Order comes into force on 24th October 2015, for an eighteen month period or completion of the works whichever is soonest. It is anticipated that the works will take approximately 10 days.
