Mae Cyngor Sir Ddinbych wedi gwneud Gorchymyn sy'n gwahardd unrhyw gerbyd rhag defnyddio'r rhan honno o ffordd Dosbarth III a elwir yn ffordd Llanfair DC i Ffolt Llanfair DC yn Sir Ddinbych, sy'n ymestyn o'i chyffordd gyda'r A525 Ffordd Wrexham i'w chyffordd â'r B5429. Mae angen cau'r ffordd i hwyluso gwaith arwynebu gan Uned Waith Cyngor Sir Ddinbych.

Bydd y llwybr arall gydag arwyddion ar gyfer traffig ar hyd y B5429 a'r A525 Ffordd Wrexham. Bydd mynediad i gerddwyr ar gael drwy gydol y cyfnod cau.

Daw'r Gorchymyn i rym ar 30 Tachwedd 2015 am gyfnod o 18 mis neu tan y bydd y gwaith wedi ei gwblhau, pa un bynnag sydd gynharaf. Disgwylir i'r gwaith gymryd oddeutu pythefnos i'w gwblhau.

NOTICE OF TEMPORARY PROHIBITION OF THROUGH TRAFFIC ORDER
ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14**

Denbighshire County Council has made an Order which prohibits any vehicle from using that length of Class III road known as Llanfair D.C. to Ffolt Llanfair DC in the County of Denbigh, which extends from its junction with A525 Wrexham Road to its junction with B5429. The closure is necessary to facilitate resurfacing works by Denbighshire County Council - Works Unit.

The signposted alternative route available for traffic will be via B5429, and A525 Wrexham Road. Pedestrian access will be maintained throughout the period of closure.

The Order comes into force on 30th November 2015, for an eighteen month period or until the completion of the works whichever is soonest. It is anticipated the works will last approximately 2 weeks.
