

On 20.01.16 Wrexham Council made The County Borough of Wrexham (One Way Traffic) (Traffic Regulation) Order 2015 to prohibit any vehicle or motor vehicle from proceeding along George Avenue, Trevor - from a point 100 metres west of its junction with B5434 Station Road to its junction with Charles Avenue Westerly; George Avenue, Trevor - from its junction with Heol Penderyst to a point 100 metres west of its junction with B5434 Station Road Easterly; Charles Avenue, Trevor - from its junction with George Avenue to its junction with Heol Penderyst Westerly; Heol Penderyst, Trevor - from its junction with Charles Avenue to its junction with George Avenue, Easterly.

A copy of the order, which will come into force on 25.01.16 may be examined at the Environment Department, Abbey Road Depot, Abbey Road South, Wrexham Industrial Estate, Wrexham, during normal office hours. If you wish to question the validity of the Order or of any provision contained within it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirements of the Act or of any instrument made under it, have not been complied with in relation to the Order, you may within six weeks from 22.01.16 apply to the High Court for this purpose.
