Ar 15 Ionawr 2016, cadarnhaodd Cyngor Sir Powys y Gorchymyn uchod a wnaed dan Adran 257 Deddf Cynllunio Gwlad a Thref 1990.

Effaith y Gorchymyn fel y'i cadarnhawyd yw gwyro'r llwybr troed yn Nhŷ Uchaf, Llanfair Caereinion sy'n rhedeg o SJ 0883,0634 i SJ 0879,0642 i linell sy'n rhedeg o SJ 0873,0635 i SJ 0874,0640 i SJ 0879,0643 ac yna i SJ 0879,0642 fel y gwelir ar fap y Gorchymyn.

**Notice of Confirmation of a  
Public Path Order**

Diversion Order 2015**

On 15th January 2016 Powys County Council confirmed the above Order made under Section 257 of the Town and Country Planning Act 1990.

The effect of the Order as confirmed is to divert the footpath at Tŷ Uchaf, Llanfair Caereinion running from SJ 0883,0634 to SJ 0879,0642 to a line running from SJ 0873,0635 to SJ 0874,0640 to SJ 0879,0643 and then to SJ 0879,0642 as shown on the Order map.

A copy of the Order as confirmed and the Order map have been placed and may be seen free of charge at Powys County Council Neuadd Maldwyn, Severn Road, Welshpool, Powys, SY21 7AS during normal office hours. Copies of the Order and Order Map may be purchased there at a price of 10 pence per sheet.

The Order came into force on the 15th January 2016 but if any person aggrieved by the Order decides to question its validity or that of any provision contained in it on the ground that it is not within the powers of the above Act, or on the ground that any requirement of that Act or any regulation made under it has not been complied with in relation to the confirmation of the Order, he or she may apply to the High Court for any of these purposes under Section 287 of the Town & Country Planning Act 1990 within six weeks from the date on which notice is first published as required by paragraph 7 of Schedule 14 to that Act.
