**GORCHYMYN CEFNFFYRDD YR A483 A'R
A489 (Y DRENEWYDD, POWYS)
(CYFYNGIADAU CYFLYMDER DROS DRO A
DIM GODDIWEDDYD) 201-**

MAE GWAINIDOGION CYMRU yn bwriadu gwneud Gorchymyn o dan adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984 ymhen dim llai na 7 niwrnod i ddyddiad yr Hysbysiad hwn. Mae angen y Gorchymyn arfaethedig er mwyn gwneud gwaith ar gefnffyrdd yr A483 a'r A489 yn y Drenewydd, Powys, neu gerllaw iddynt.

Disgwylir y bydd y cyfyngiadau a'r gwaharddiad, y codir arwyddion priodol yn eu cylch, yn dod i rym am 08:00 o'r gloch ar 7 Mawrth 2016 a byddant yn parhau am 18 mis ar y mwyaf.

Effaith y Gorchymyn arfaethedig fydd gosod terfyn cyflymder dros dro o naill ai 30 mya, 20 mya neu 10 mya a gwahardd goddiweddyd ar y darnau canlynol o gefnffyrdd yr A483 a'r A489:

- i. y darn hwnnw o'r A483 sy'n ymestyn tua'r de-orllewin o derfynfa'r terfyn cyflymder 30 mya i'r de o'i chyffordd â Ffordd Dolfor Uchaf hyd at bwynt 465 o fetrau i'r de o ganolbwynt y fynedfa i Ffrydd Vaughan, y Drenewydd;
- ii. y darn hwnnw o'r A483 sy'n ymestyn tua'r dwyrain o derfynfa'r terfyn cyflymder 40 mya presennol ger Gro Cottages, Pool Road, y Drenewydd hyd at bwynt 228 o fetrau i'r gorllewin o ganolbwynt ei chyffordd â ffordd ddiddosbarth yr U2647 i Froniarth;
- iii. y darn hwnnw o'r A489 sy'n ymestyn tua'r gorllewin o ochr gorllewinol Cylchfan Mochdre, y Drenewydd hyd at bwynt 517 o fetrau i'r gorllewin o ganolbwynt y fynedfa i Glanhafren Hall.

**THE A483 & A489 TRUNK ROADS
(NEWTOWN, POWYS) (TEMPORARY SPEED
RESTRICTIONS AND NO OVERTAKING)
ORDER 201-**

THE WELSH MINISTERS propose, in not less than 7 days from the date of this Notice, to make an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary to undertake works on or near the A483 and A489 trunk roads at Newtown, Powys.

It is expected that the restrictions and prohibition, which will be signed accordingly, will come into force at 08:00 hours on 7 March 2016 and remain for a maximum duration of 18 months.

The effect of the proposed Order will be to temporarily impose a 30 mph, 20 mph or 10 mph speed limit and prohibit overtaking on the following lengths of the A483 and A489 trunk roads:

- i. the length of the A483 that extends in a south-westerly direction from the existing 30 mph speed limit terminus south of its junction with Upper Dolfor Road to a point 465 metres south of the centre-point of the access to Ffrydd Vaughan, Newtown;
- ii. the length of the A483 that extends in an easterly direction from the existing 40 mph speed limit terminus near Gro Cottages, Pool Road, Newtown to a point 228 metres west of the centre-point of its junction with the unclassified road U2647 to Broniarth;
- iii. the length of the A489 that extends in a westerly direction from the western side of Mochdre Roundabout, Newtown to a point 517 metres west of the centre-point of the access to Glanhafren Hall.
