**Rhoddir rhybudd drwy hyn** fod Cyngor Sir Powys wedi gwneud Gorchymyn o dan Adran 84(1)(a) a (2) Deddf Rheoli Traffig y Ffyrdd 1984, fel y'i diwygiwyd.

Bydd y Gorchymyn, a ddaw i rym ar ddydd Mawrth 1 Medi 2009, yn ei gwneud yn anghyfreithlon i yrru cerbyd ar gyflymder uwch nag ugain milltir yr awr ar y rhan honno o'r ffordd a nodir yn yr Atodlen i'r Rhybudd hwn. Bydd mesurau arafu traffig eraill ar y ffordd a fydd yn creu parth cyfyngiad cyflymder 20 mya.

**Notice is hereby given** that Powys County Council has made an Order under Section 84(1)(a) and (2) of the Road Traffic Regulation Act, 1984, as amended.

This Order which comes into effect on Tuesday 1<sup>st</sup> September 2009, makes it unlawful to drive a vehicle at a speed exceeding twenty miles per hour in that length of road specified in the Schedule to this Notice. This length of road will also be subject to other traffic calming measures so that it will form a 20 mph speed limit zone.

A copy of the Order, together with a map showing the length of road concerned and a statement of the Council's reasons for making the Order, may be examined during office hours at County Hall, Llandrindod Wells.

If you wish to question the validity of the order, you may within 6 weeks from the 1<sup>st</sup> September 2009 apply to the High Court for this purpose.
