effect of the Order will divert the
public footpath commencing at
SN9103,9185 at Waen y Gittin
running to SN9098,9188 to a line
running from SN9103,9185 to
SN9102,9186 to SN9100,9187
to SN9098,9188 as shown on the
Order Map.

A copy of the Order and the
Order Map have been placed and
may be seen free of charge at
Powys County Council, Neuadd
Maldwyn, Severn Road, Welshpool
during normal office hours. Copies
of the Order and map may be
purchased there at a price of 10p
per sheet.

Any representations about or
objections to the Order may be
sent in writing to the Head of legal
Services Powys County Council
Neuadd Maldwyn Severn Road
Welshpool Powys not later than 14
December 2009 and the applicants
are requested to state the grounds
on which they are made.

If no such representations or
objections are duly made, or if any
so made are withdrawn, the Powys
County Council may confirm the
Order as an unopposed Order. If
the Order is sent to the National
Assembly for Wales for confirmation
any representations or objections,
which have been withdrawn, will be
sent with the Order.
