Mae angen y Gorchymyn oherwydd y tebygrwydd o berygl i'r cyhoedd.

Bydd y llwybr arall o gyfeirnod grid SH8521 7778 gan barhau tua'r de-orllewin am tua 180m i llwybr troed 31 yna troi a mynd tua'r gogledd am tua 160m i gyfeirnod grid SH8510 7783.

Daw'r Gorchymyn i rym ar 3 Chwefror 2010. Disgwylir y bydd y llwybr troed ar gau nes bydd y gwaith y bwriedir ei wneud wedi ei gwblhau, ond am gyfnod o ddim mwy na 6 mis.

ROAD TRAFFIC REGULATION ACT 1984

SECTION 14(1)

The County Borough of Conwy

(Footpath 33 in the Community of Colwyn Bay)

(Temporary Prohibition of Pedestrians)

Order 2010

NOTICE IS GIVEN that the Conwy County Borough Council has made an Order, the effect of which is to prohibit any pedestrian to proceed in that length of Footpath 33 in the Community of Colwyn Bay in the County Borough of Conwy commencing at grid reference SH8521 7778 and continuing in a generally westerly direction for approximately 130m to grid reference SH8510 7783.

The Order is necessary for the reason of likelihood of danger to the public.

The alternative route will be from grid reference SH8521 7778 continuing in a south westerly direction for approximately 180m to footpath 31 then turning and heading in a northerly direction for approximately 160m to grid reference SH8510 7783.

The Order will come into effect on 3 February 2010. It is anticipated that the footpath will be closed until the works which it is proposed to carry out have been completed, subject to a maximum period of 6 months.
